Free Tax Help For Qualifying Tax Filers:

- **Tax Help Colorado** offers free tax help to Coloradans earning less than \$53,000. Dial 2-1-1 or visit www.piton.org/eitc.
- **Volunteer Income Tax Assistance** (VITA) sites offer free tax help to people who generally make \$54,000 or less, persons with disabilities and limited English speaking taxpayers who need assistance in preparing their own tax returns. IRS-certified volunteers provide free basic income tax return preparation with electronic filing to qualified individuals.
