## **Sister Simone Campbell**


Simone Campbell has served as Executive Director of NETWORK since 2004. She is a religious leader, attorney, and poet with extensive experience in public policy and advocacy for systemic change. In Washington D.C., she works on issues that help "mend the gaps" in income and wealth in the U.S., focused specifically on how they disproportionately affect people of color and women. Around the country, she is a noted speaker and educator on these public policy issues.

During the 2010 congressional debate about healthcare reform, she wrote the famous "nuns' letter" supporting the reform bill and got 59 leaders of Catholic Sisters to sign on. This action was cited by many as critically important in passing the Affordable Care Act.

She has led five cross-country "Nuns on the Bus" trips, focused on economic justice, comprehensive immigration reform, voter turnout, bridging divides in politics and society, and (most recently) mending the gaps in wealth and access in our nation.

She is also the author of A Nun on the Bus: How All of Us Can Create Hope, Change, and Community.
