	Family Planning Services Program	Reproductive Health Care Services Program
Program Description	<ul style="list-style-type: none"> <li>Extends coverage of family planning services to Coloradans at or below 260% of the federal poverty level (FPL) who don't qualify for Health First Colorado (Colorado's Medicaid program) because they are over income.</li> <li>Applicants can request retroactive coverage for family planning services received in the 90 days before they applied.</li> <li>Members are enrolled for 12 months.</li> <li>No restrictions on age or gender.</li> </ul>	<ul style="list-style-type: none"> <li>Extends coverage of reproductive health care services to Coloradans who don't qualify for Health First Colorado due to their immigration status.</li> <li>Applicants can request retroactive coverage for reproductive health services they received in the 90 days before they applied.</li> <li>Members are enrolled for up to 12 months.</li> <li>No restrictions on gender (age cut-off is 65 years)</li> <li>Members with Emergency Medicaid automatically have this program as a benefit.</li> </ul>
Eligibility	<ul style="list-style-type: none"> <li>Incomes between 139% - 260% FPL.</li> <li>U.S. citizen, lawfully present children (under 19 years old), or lawfully present adult for at least five years to qualify.</li> </ul>	<ul style="list-style-type: none"> <li>Incomes up to 138% FPL for adults, 147% FPL for children, and 200% FPL for pregnancy.</li> <li>Deferred Action for Childhood Arrivals (DACA), adults who have been lawfully present in the U.S. for less than five years, or people without immigration documentation.</li> </ul>
Other Insurance	Members eligible for these programs can have other kinds of insurance and still be eligible. Members are eligible for tax credits through Connect for Health Colorado with these programs because they do not include full benefits.	
What is Covered?	<ul style="list-style-type: none"> <li>Contraceptive drugs, devices, or products (such as birth control pills, patches, Depo shot, IUDs, vasectomy, tubal ligation etc.).</li> <li>Device insertion and removal.</li> <li>Office visits related to administering and monitoring contraceptive products, including managing side effects.</li> <li>Family planning office visits (helping a client decide whether to become a parent or when to become a parent).</li> <li>Diagnosis, treatment, prevention and follow up visits for STI, STD, and UTI if diagnosed at a family planning visit.</li> <li>Cervical cancer screening and prevention.</li> <li>Pregnancy test.</li> </ul>
